All this from a passing tip from me, and help from a manager in Zellers in Windsor, Ontario.

### NOTICE OF A PUBLIC MEETING

#### WARD 1

Concerning Applications to Amend the Town of Halton Hills Official Plan and Zoning By-law

For lands located at 163 Church Street Lots 50 and Part of Lot 51, 52, and 53, Block 8 Lots 8 and 9, Block 21, Registered Plan 31 Town of Halton Hills (Acton)

Town of Halton Hills Files  
D09OPA06.004 & D14ZBA06.005  
(Acton Medical Centre, 163 Church Street)

The General Committee for the Town of Halton Hills will conduct a Public Meeting to examine and discuss proposed amendment applications to the Town of Halton Hills Official Plan and Zoning By-law 1358, as amended. The proposed amendments apply to the property municipally known as 163 Church Street, Town of Halton Hills (Acton). The subject land is bounded by Mill Street, Eastern Avenue, Church Street, and Fellows Street. The site is currently vacant.

Below is a map showing the location of the subject property to which the proposed Official Plan Amendment and Zoning By-law Amendment would apply.

The purpose and effect of the proposed amendment applications are to permit the development of a medical centre, with medical offices, dental offices, and limited commercial service uses on the subject site. The property is currently designated "Special Purpose Commercial Area" by the Town of Halton Hills Official Plan. The applicant is proposing to change the designation to "Core Commercial", which would allow the proposed uses.

The subject lands are zoned Industrial Light (M1) Zone by Zoning By-law 1358. The applicant is requesting to change the zoning for the subject property to a site-specific "General Commercial Special" (C1-1) Zone, to permit a medical centre.

If you wish to be notified of the decision of the Town of Halton Hills in respect of this proposed Official Plan Amendment and/or if you wish to be notified of the decision of the Town of Halton Hills in respect of this proposed Zoning By-law Amendment, you must make a written request to the Town of Halton Hills at 1 Halton Hills Drive, Halton Hills, Ontario L7G 5G2.

If a person or public body that files a notice of appeal of a decision of the Town of Halton Hills in respect of the proposed Official Plan and/or Zoning By-law Amendment does not make oral submissions at a public meeting or make written submissions to the Town of Halton Hills before the proposed Official Plan and/or Zoning By-law Amendment is adopted, the Ontario Municipal Board may dismiss all or part of the appeal.

**NOTE:** Any written comment/objection submitted to the Town of Halton Hills regarding this application(s) which is being processed under the Planning Act 1990, may be made public as part of the application process.

This position is responsible for managing a Cultural Centre, which includes a performing arts theatre and art gallery. This position will work with local performing and visual arts groups to promote and develop arts and culture in the community; maximize use of community arts and culture resources; provide complete oversight of centre operations in cooperation with Library Services located within the same building; oversee conservation planning; and be responsible for project management for assigned infrastructure work as part of the Department Administrative Team.

#### Responsibilities:

- Project management of capital projects, community events, service delivery improvement and business plans.
- Develop short and long term plans and policies for programs, services and operations based on current and future trends, changing community demographics and impact on community responsive services including recommendations for facility modifications and additions.

- University degree or equivalent in recreation, business or related field
- Minimum of 5 years of progressively responsible experience in recreation/administration and/or facility management at the Supervisory level including 3 years experience with performing arts and theatre operations.
- Knowledge of community cultural pursuits and activities is required.
- Superior communication skills, verbal and written.
- Proven Supervisory leadership and team building skills required.
- Experience in working effectively with community agencies, Council, community groups, the media and public.
- Strong understanding and knowledge of facility maintenance and operational issues pertaining to use of a public facility.
