

Youths recognized for community spirit

Three local youths were among more than 100 nominees for this year's Ontario Community Newspaper Association (OCNA) Junior Citizen of the Year Awards.

Nominated in Halton Hills were Laura Crawford, 14, Heather MacKinnon, 17, of Georgetown and Noah MacDonald, 10, of Acton.

The youths, nominated through *The Independent & Free Press* are recognized annually by the Ontario Community Newspapers' Association (OCNA) and its Junior Citizen of the Year competition, for their outstanding contributions

to their communities as leaders of tomorrow.

None of the three Halton Hills nominees were selected as winners in the competition. There were 12 winners from across the province.

Crawford is a member of the 756 Wild Goose Squadron, Royal Canadian Air Cadets and the Precision Drill Team.

At school she is enrolled in the International Prep program and is a member of the Athletic Council, School Band, Junior Girls Varsity Basketball Team and also plays recreational soccer.

Last year she was also chosen to attend the U.S. Space and Rocket Centre in Huntsville, Alabama for a week where she was named the "Astronaut with the Right Stuff."

Last year while in Grade 8, Crawford won the Mathematics and Science award. Through her involvement with the Cadets she carries out citizenship duties including poppy sales for the legion, Remembrance Day parades, serving at veteran's and legion award dinners, and as a band member in Santa Claus parades. She has also participated in the Bell

Walk for Kids helping to raise money for the Kids Help Phone.

MacKinnon received the nomination for being a "self-motivated, community driven, people person."

She was the valedictorian of her Grade 8 class, was appointed to the Halton Catholic District School Board as a student trustee for the 2006/07 school year and her involvement as a volunteer on various initiatives such as Crop for Cancer, Relay for Hope, Walk for Prader-Willi Syndrome and North Halton Women's Institute.

Recently MacKinnon and her sister Karen hosted a successful fundraiser in town raising more than \$7,550 in total to be split between three different cancer charities. They held the fund-

Concerning Applications to Amend the Town of Halton Hills Zoning By-law For land located at 89 Mill Street Part of Lots 26 and 27, Block 5 Registered Plan 31 Town of Halton Hills (Acton)

Town of Halton Hills Files D14ZBA07.002 (H.E.L.P. Safety Services, 89 Mill Street)

The General Committee for the Town of Halton Hills will conduct a Public Meeting to examine and discuss a proposed amendment application to the Town of Halton Hills Zoning By-law 1358, as amended. The proposed amendment applies to the property municipally known as 89 Mill Street, Town of Halton Hills (Acton).


Below is a map showing the location of the subject property to which the proposed Zoning By-law Amendment would apply. There is currently a residential dwelling on the site.

The purpose and effect of the proposed amendment application are to allow the existing building to be used as a business office. The subject lands are zoned "Commercial - General (Holding)" (C-1 (H)) by Zoning By-law 1358. The applicant is requesting to change the zoning for the subject property to a site-specific "General Commercial - Special" (C1-1) Zone, to permit the conversion to a business office.

If you wish to be notified of the decision of the Town of Halton Hills in respect of this proposed Zoning By-law Amendment, you must make a written request to the Town of Halton Hills at 1 Halton Hills Drive, Halton Hills, Ontario L7G 5G2.

If a person or public body that files a notice of appeal of a decision of the Town of Halton Hills in respect of the proposed Zoning By-law Amendment does not make oral submissions at a public meeting or make written submissions to the Town of Halton Hills before the proposed Zoning By-law Amendment is adopted, the Ontario Municipal Board may dismiss all or part of the appeal.

NOTE: Any written comment/objection submitted to the Town of Halton Hills regarding this application(s) which is being processed under the Planning Act 1990, may be made public as part of the application process.

OVERNIGHT PARKING RESTRICTION

Uniform Traffic Control By-law No. 84-1 prohibits parking:

2:00 A.M. – 7:00 A.M. (Daily)
November 15, 2006 to April 15, 2007

On all streets under the jurisdiction of the Town of Halton Hills, unless authorized signs indicating otherwise are specifically posted. Motorists are reminded that By-law No. 84-1 also prohibits the parking of a vehicle on all Town or Regional Roads for longer than 3 consecutive hours at any single location, unless otherwise specifically posted.

On-street parking hinders snow clearing and other road maintenance operations. Your co-operation is requested. Please comply with the requirements of this By-law.

AUTHORITIES MAY HAVE VEHICLES TICKETED OR TOWED AWAY AT THE OWNER'S EXPENSE.

Motorists should note that Town By-Law Enforcement Officers will be on patrol through the duration of the parking restriction period and will ticket and/or have the offending vehicle removed. Enforcement Officers will not enforce parking on sidewalks between 2:00 a.m. and 7:00 a.m. where the Town does not clear the sidewalks.

SNOW REMOVAL

The placing or pushing of snow or ice onto roadways or cleared sidewalks will obstruct or encumber vehicular and pedestrian traffic. Do not push snow across roadways because the trail of snow does turn to ice. The Town's Obstruction, Encumbering or Fouling of Highways By-law No. 90-68 prohibits such action.

Improper snow and ice clearing can be a serious hazard to motorists and pedestrians. Your co-operation is requested. Please comply with the requirements of this By-law.

Be alert for snow plows and stay back at least 15 meters behind snow plow trucks. Please avoid parking on streets during snowstorms to assist Public Works operations staff with providing safe, passable roads.
