General Committee for the Town of Halton Hills will conduct a Public Meeting to examine and discuss a proposed Common Element Condominium application and a related Part Lot Control application. The proposed applications apply to the property known as Block 72, 20M-978, Town of Halton Hills (Georgetown).

Below is a map showing the location of the subject property to which the applications apply.

The purpose and effect of the applications are to facilitate the establishment of a common element condominium with a private lane and amenity space. A 39 unit townhouse development has been approved and is currently being constructed on the property.

The subject property is designated Medium Density II Residential under the Town of Halton Hills Official Plan and is zoned Fourth Density Residential Special (R4-1) under Zoning By-law 57-91.


If a person or public body does not make oral submissions at a public meeting or make written submissions to the Town of Halton Hills in respect of the proposed plan of condominium before the approval authority gives or refuses to give approval to the draft plan of condominium, the person or public body is not entitled to appeal the decision of the Town of Halton Hills to the Ontario Municipal Board.

If a person or public body does not make oral submissions at a public meeting, or make written submissions to the Town of Halton Hills in respect of the proposed plan of condominium before the approval authority gives or refuses to give approval to the draft plan of condominium, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Municipal Board unless, in the opinion of the Board, there are reasonable grounds to do so.

**NOTE: Any written comments/objections submitted to the Town of Halton Hills regarding this Application(s) which is being processed under the Planning Act 1990, may be made public as part of the application process.**

If you wish to be notified of the decision of the Town of Halton Hills in respect of this proposed Common Element Condominium application, you must make a written request to the Town of Halton Hills - PLANNING & DEVELOPMENT DEPARTMENT at 1 Halton Hills Drive, Halton Hills, Ontario L7G 5G2.

# New centre will play host to several Acton Fall Fair events

The 94th edition of the Acton Fall Fair, set for Sept. 14-16, will feature the opening of the new community centre on the grounds, an event worthy enough to be christened by "The King".

Some of the fair's highlight attractions for this year's weekend of festivities will move into the Acton Agricultural Society's Dufferin Community Centre, located just inside the front gates of the Prospect Park Fairgrounds. The new building will provide 26,000 square feet of space along with an adjacent playing field to accommodate more visitors and exhibitors.

"It's a multi-purpose facility that gives us a lot of flexibility," said AAS president Dale Hewitt. "The home crafts people will now be indoors and we should have room for about 500 to 600 people to watch the entertainment shows that we have every year."

As well as the popular Miss Acton and Baby Show, the 2007 Leathertown fair welcomes three performers who are expected to draw many fans of Elvis Presley to the new venue. Celebrated tribute artists Justin Edwards of Roland, Oklahoma, Toronto's

Gino Minopoli and Irv Cass of Fenton, Michigan have starred at recent Collingwood Elvis Festivals and organizers hope the Saturday night show will be a big attraction.

"These three tribute artists finished in the top 20 at the world competition and we're excited to bring them into the fair," Hewitt added.

Alysha Brooke will perform Sunday in the community centre with shows at 1 and 3 p.m.

Also new this year is an agricultural awareness tent with displays and presentations, along with fair mainstays such as Saturday's heavy horse show, truck and tractor pull, cattle show and the noontime parade.

Robertson Amusements will operate a midway and the Northern Borders Flyball & Canine Performance Team have demonstrations set for Saturday afternoon.

Admission is \$8 for adults, \$7 for youths (13-17) and seniors, \$3 for children (under five admitted free), or \$18 for a weekend pass. Parking is \$5 per vehicle.
