Halton public school board accepting registrations for Kindergarten this month

The Halton District School Board is now accepting registrations for Junior and Senior Kindergarten for September 2008.

Drop by or call your designated elementary school to find out what dates have been established for Kindergarten sign-up.

To register for fall 2008, Junior Kindergarten children must be four years old by Dec. 31, 2008 and Senior Kindergarten children must be five years old by Dec. 31, 2008.

Parents/guardians must also be public school tax supporters.

The registration deadline is Friday, Feb. 8.

When registering parents/guardians must bring the following original documents:

- Proof of your child's age (birth certificate or passport)
- Child's immunization record
- Child's Ontario Health Card
- Proof of address
- If you are not the child's parent,

bring proof of custody (a court order).

Parents with children who will attend Junior or Senior Kindergarten at one of the new schools still under construction should register at the school they would be slated to attend under the current school assignments.

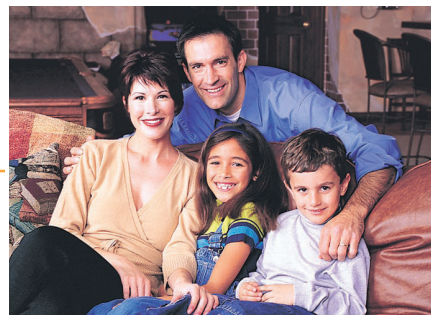
