

Tomato and Zucchini Soup with Fresh Parmesan

Ingredients

- 4 fresh tomatoes, medium size
- 1/2 large zucchini or two small
- 1 carrot, diced
- 2 stalks celery, diced
- 1/4 Spanish onion, diced
- 1 clove garlic, minced
- 1/2 orange pepper (or yellow or red pepper)
- 3 tbsp olive oil
- 8 cups chicken or vegetable stock
- 1 19oz can tomato sauce
- 3 tbsp dry onion soup mix
- 1/4 cup fresh parsley, chopped
- 1/4 cup fresh basil, chopped
- 1 tbsp coarse salt

- 1 tsp fresh ground pepper
- 1 cup fresh grated parmesan

Method

1. Heat olive oil, then sauté carrots, onions, pepper and celery until softened and translucent. Add garlic and sauté a couple of minutes.
2. Add diced fresh tomatoes with skin and seeds. Also add zucchini including skin but remove the seeds.
3. Continue simmering for about 10 minutes until juices start to come out of the tomatoes. Be careful not to burn or brown.



4. Add the chicken stock and tomato sauce and onion soup powder. Bring up to a boil.
5. Reduce heat and cover pot. Simmer for approximately 30 minutes.
6. Add fresh herbs, salt and pepper and taste to adjust seasoning if necessary. Simmer five more minutes, until herbs are incorporated.
7. Serve with freshly grated Parmesan cheese on the side.

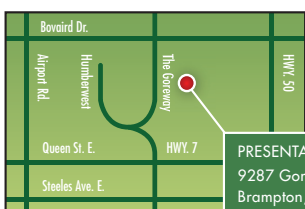
