NOTICE OF COMPLETION

GEORGETOWN WATER PURIFICATION PLANT EXPANSION AND UPGRADES CLASS ENVIRONMENTAL ASSESSMENT

Halton Region has undertaken a Class Environmental Assessment (Class EA) study for the provision of additional water treatment capacity at the Georgetown Water Purification Plant (WPP) and upgrades to the existing facility including a new standby generator, office space and workshop.

receipt of necessary approvals (including the Cedarvale Well Field re-rating project) and funding, Halton Region intends to proceed with the design and construction of this project immediately. If the Cedarvale Well Field re-rating project does not proceed, the upgrades to the Georgetown WPP will still proceed to design and construction.

An Environmental Study Report (ESR) for the Georgetown WPP Expansion and Upgrades Class EA which documents all phases of the Municipal Class Environmental Assessment process has been prepared. The ESR is posted on the Halton Region website and is also available for viewing for 30-calendar days from November 9, 2007 to December 10, 2007 at the following locations:

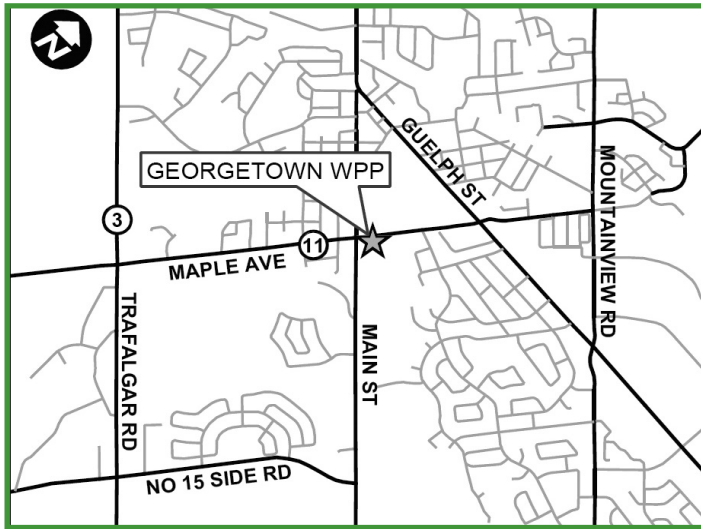


Figure 1 – Study Area Map

One of the projects identified in the *Georgetown Water Supply Master Plan Review* (Halton Region, June 2003) is to provide future growth in the Georgetown urban area and nearby hamlets of Stewarttown, Glen Williams and Norval with municipal water supply through a re-rating of the Cedarvale Well Field. Groundwater pumped from the Cedarvale Well Field is treated at the Georgetown WPP. If approvals are granted for the Cedarvale Well Field re-rating project, the Georgetown WPP will require a treatment system expansion. Also, as part of Halton Region's ongoing Asset Management program, the Georgetown WPP requires a number of upgrades including, a new standby generator, office space and workshop.

The preferred solution for the Georgetown WPP Expansion is to increase the existing plant's rated capacity from 100 L/s (8,640 m³/day) to 151 L/s (13,091 m³/day) by adding a third filter and new ultra-violet (UV) disinfection unit. The preferred solution for the Georgetown WPP Upgrades is to install a standby generator in a new building extension to the west of the existing building, construct a new workshop to the east of the filtration building, and construct a building extension for offices to the south of the filtration building.

The study is being conducted in accordance with the requirements of a Schedule 'C' project under the Municipal Class Environmental Assessment (June 2000), which is an approved process under the *Ontario Environmental Assessment Act*. Subject to comments received as a result of this Notice, the
