You are invited to attend a Public Information Meeting to be held by the Council for the Corporation of the Town of Caledon to consider an Official Plan Amendment. Your attendance and comments at this meeting are welcome as it is your opportunity to learn more about the application and express any opinions that you may have.

Mandatory Pre-Consultation and Complete Application Requirements

#### PROPOSAL

The proposal is to add policies to the Town of Caledon's Official Plan with regard to mandatory pre-consultation and complete application requirements; and, to implement the mandatory pre-consultation meeting process by by-law.

#### PURPOSE AND EFFECT OF THE PROPOSED AMENDMENT

The purpose of the proposal is to implement a tool provided by the Planning Act, as amended, that allows a municipality to request mandatory pre-consultation meetings with potential applicants, and further, to outline in its Official Plan the studies and materials needed (in addition to statutory requirements) for the municipality to declare an application to be complete.

The effect of the proposal is to require applicants proposing to submit an application for an Official Plan amendment, Zoning By-law amendment, draft plan of subdivision, draft plan of condominium, site plan, and/or consent from the Committee of Adjustment, to attend a mandatory pre-consultation meeting during which Town staff will identify and finalize the studies and materials needed to process the file. The proposed policies outline a required list of studies and materials, and provide Town staff the ability to request additional material as well as exempt the proposal from certain submission requirements in accordance with the existing policies in the Official Plan. Furthermore, the proposed policies outline the specific items that would allow the Town to respond to the applicant regarding the completeness of an application.

In association with the proposed Official Plan Amendment, the proposed mandatory pre-consultation by-law would authorize and direct Town staff to conduct such meetings with proponents in accordance with the criteria set out in the by-law and in the Official Plan.

#### INFORMATION AVAILABLE FOR INSPECTION

A copy of the proposed Official Plan Amendment and associated information and material is available to the public for inspection in the Planning and Development Department. Office hours are Monday to Friday from 9:00 a.m. to 4:30 p.m. Written submissions may be mailed or personally delivered to the Planning and Development Department at the address noted below.

#### NOTIFICATION

If you wish to be notified of the adoption of the proposed Official Plan Amendment you must make a written request to the Town of Caledon, Planning and Development Department, 6311 Old Church Road, Caledon, Ontario L7C 1J6.

#### APPEAL PROCEDURES

If a person or public body does not make oral submissions at a public meeting or make written submissions to the Town of Caledon before the proposed Official Plan amendment is adopted, the person or public body is not entitled to appeal the decision of the Town of Caledon to the Ontario Municipal Board.

If a person or public body does not make oral submissions at a public meeting or make written submissions to the Town of Caledon before the proposed Official Plan amendment is adopted, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Municipal Board unless, in the opinion of the Board, there are reasonable grounds to add the person or public body as a party.
