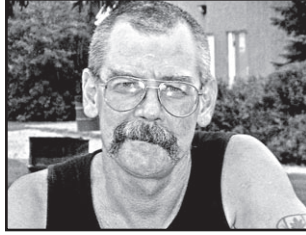


# VOX POP

## August start for new bandshell in park
