Hydro One's corridor should include built-in protection

To the editor:

Hydro One is attempting to have their Bruce to Milton Transmission Project approved. I am willing to accept that Ontario requires more transmission capacity and that Bruce One and Two are returning to service. Thus, they claim, the line must be built. I add that the project should include built-in protection against outages. In fact, there is a well established, proven technology that satisfies all these without new transmission lines.

Now the industry standard world wide, it has been approved for other Hydro One projects across Ontario, but not for this one.

I offer this loose analogy for comparison: the alternate technology as a household electrical system with insulated, grounded wires and circuit-breaker panels. The transmission line as pre-1940s household electrification. Bare, ungrounded wires, strung through glass or ceramic insulators, nailed to wood either within or on the walls, and a fuse box.

(This technology still exists in many third world locations today. However, these areas are striving to bring their lowest to highest tier electrification to the present. Capacitor enhancement for all more recent transmission lines and all new transmission lines, where these are absolutely necessary.)

Why is Hydro One so hidebound and resolute in their desire to saddle our new house with 1930's bare wire and fuse technology? Lastly, the capacitor enhancement is but 15 to 30% of the \$630 million cost of a new, unprotected, transmission line, which we will all end up chipping in for.
