New development charges now in effect

New development charges in Halton Hills, which came into effect on the first day of September, 2007, were passed by Council on August 13.

According to Council, the new charges imposed under Bylaw 2007-0083 are required to pay for the increased capital costs related to the increased need for municipal services arising from development in Halton Hills. The development charges include all lands within the Town, urban and rural.

participants who lapped the track, so to speak. Popular areas included the Terry Fox display, the memory board where people could dedicate their run to loved ones, and of course the food booth, which served the now famous Wallywhopper, Wallyclucker and Wallyporker.

All food products were donated, with proceeds from the booth added to the day's total. At the end of the day \$24,500 was raised in Terry's name, bringing Acton's 27 year total to \$585,000 raised for cancer research.

Terry once said "Even if I don't finish, we need others to continue. It's got to keep going without me." Twenty-eight years later, the people involved with the Acton Terry Fox Run have shown, through participating, sponsoring and volunteering, that Terry's dream will continue.

New development charges include:

Single Detached and Semi-Detached Dwellings (per unit) \$12,063.00.

Row Dwelling, 3 or more bedrooms (per unit) \$10,118.00.

Row Dwelling, 1 or 2 bedrooms (per unit) \$ 6,226.00.

Apartments, 2 or more bedrooms (per unit) \$ 5,837.00

Apartments, 1 bedroom (per unit) \$ 4,281.00.

Special Care/Need Dwelling \$ 3,891.00.

Non-Residential, Industrial (per sq. m.) \$23.06.

Non-Residential, Other Non Industrial (per sq. m.) \$57.12.

Any person or organization may appeal the bylaw to the Ontario Municipal Board under Section 14 of the Development Charges Act by filing a notice of appeal to the Clerk of Halton Hills

on or before 4:30 p.m. on September 24, 2007, setting out the objection to the bylaw and reasons for supporting the objection.

A copy of the complete by-law is available for examination during regular business hours (weekdays from 8:30 a.m. to 4:30 p.m.) in the office of the Clerk at The Town of Halton Hills Civic Centre, 1 Halton Hills Drive, Georgetown.
