## Vote \$90,000 for consultant's assessment of old bridge

The bridge was built in 1877, and because of its age it may have historical and cultural aspects. The consultant will re-

The consultant, R.J. Burnside and Associates Limited, will also do an in-depth condition assessment of the structure and develop an alternative repair/replacement strategies for public review.


Regional and Town Councillor Jane Fogal questioned why they would spend so much to determine if the bridge has historical significance, which they

already believe it has, and to assess its condition.

"Is that all we get for \$90,000? We don't get the design of a bridge, exactly what do we get?" Fogal asked engineer Chris Mills who said they wouldn't come out of the study with actual construction drawings, but would get functional designs and a very clear understanding of what is to be constructed.

A 2008 structure condition report for the culvert shows stone loss and mortar deterioration and the railing/guide rail system on the bridge does not meet current standards

# Town says new medical centre in doctor's hands

The Town is prepared to move ahead with the planning process to develop a medical centre on vacant land in Acton, but the next move is up to the applicant, Dr. Nather Alshakarji.

Town planner Adam Farr said Dr. Ålshakarji is "pretty much in a position to move forward if he wants," and there are no outstanding planning issues that must be resolved before the application can move ahead. "To proceed, all he (Dr. Alshakarji) has to do is sign the final documents and that's it," Farr said on Friday adding that the Town is in a state of readiness with the file.

Under the name Acton Medical & Urgent Care Clinic, Dr. Alshakarji plans to build a one storey, 10,204-square foot facility on vacant property bounded by Church Street, Mill Street, Eastern Avenue and Fellows Street.

Dr. Alshakarji has signed a site plan approval agreement with the Town, entered

into agreement with the Town to use Town-owned parking space across Eastern Avenue adjacent to the Hide House and received confirmation of a water allocation from Halton Region. Initially, the plans called for a two-storey building with a café and doctor's residence. As proposed, the front of the building faces Eastern Avenue where the main entrance is located and there is

an entrance/exit onto Church Street.

Dr. Alshakarji's planner, Glenn Wellings, said on Friday that he did not know why the project was delayed other than he'd heard that "some of the costings were higher than expected.'

Prior to press time, several attempts to reach Dr. Alshakarji for comment were unsuccessful.
