# Federal Gas Tax Award for GreenCart program

Halton received accolades from the federal minister of state and the Association of Municipalities of Ontario (AMO) as well as an honourable mention award for its separated source organic composting program funded almost entirely with revenue from the federal gas tax.

The Region delivered "Green-Cart" organic waste bins to 140,000 homes in Halton during 2008. The \$3.4 million project diverted 18,000 tonnes of compost material from a landfill environmentally sustainable between April and December, 2008.

The AMO Federal Gas Tax Awards honour municipalities that have demonstrated excellence in the use of Federal Gas Tax Funds with projects that exemplify the fund's environmental and community sustainability objectives.

Federal Gas Tax Funding provides municipalities with long-term, funding for

infrastructure that helps achieve cleaner water, cleaner air, or reduce greenhouse gas emission. Project categories include public transit, local roads and bridges, water and wastewater, solid waste management and community energy systems.

"Weekly use of the GreenCart coupled with the Blue Box has led to the success of diverting 60% of residential waste away from the landfill, an incredible

Thanks to the participation efforts of Halton residents, approximately 40,000 tonnes of yard waste was collected last year and turned into rich, garden-friendly compost. Halton residents are invited to come out to the Fall Compost Give Away to pick up some of this compost as a 'Thank You' for helping divert a usable material from the landfill, thereby extending its life!



- All Halton households are welcome to collect a maximum of seven bags (or equivalent) of compost.
- Please bring your own containers (garbage bags, yard waste bags, reusable containers, pick-up bed, trailer, etc.) and shovel.
- Residents are responsible for shovelling and bagging their own compost.
- Non-perishable food items or cash donations will be gratefully accepted on behalf of Halton area food banks.

Helpful Hint - When applying your compost to your gardens, ensure you blend it with topsoil or another gardening fill. Recommended application for best growing results is a 60/40 split (60% topsoil and 40% compost).

The following materials will be accepted for collection free of charge:

Household Hazardous Waste (HHW)

Acceptable materials include: pesticides, paint, stains, motor oil, antifreeze, varsol, fuels, cleaners, pool chemicals, pharmaceuticals, propane tanks, household batteries, car batteries, and fluorescent tubes and bulbs.



Unacceptable materials include: needles, syringes and lancets, asbestos, commercial and industrial waste, PCBs, explosives, and ammunition.

#### Electronics

- Acceptable items include: computers, stereos, phones, TVs, VCRs, DVD players and computer monitors
- Unacceptable materials include: metal and appliances, wooden console TVs, microwaves and scrap metal

#### If you are unable to attend the Special Waste Drop-off Days:

- Household hazardous waste can be dropped off free of charge at the Household Hazardous Waste Depot located at the Halton Waste Management Site (HWMS), 5400 Regional Road 25, Milton. There is a 20 litre maximum per visit.
- Electronics are also accepted at the HWMS for a charge.
