Careless butts cause fires

With an increase in the variety of garden coverings such as landscape fabrics, peat moss, compost materials and decorative colored mulches, the number of calls to the Fire Department Staff are also increasing. While aesthetics are becoming more and more important to both the business and home owners, there is serious concern for substantial fire damage from a carelessly discarded cigarette butt.

Past incidents that Fire Department staff has responded to include a bottom of a plastic flower pot that got so hot it discolored the coffee table it was sitting on. A match thrown into a container mixed with a quantity of peat moss generated such extensive smoke that someone called and reported a possible garage fire. A number of




plastic patio flower pots, plastic pots sitting on a wooden deck, clay pots with smoldering peat moss and compost products. In some cases, people have been home to discover this, so we have been very lucky that nothing more serious resulted.

Various businesses and stores are also spending a lot of money and effort in decorating gardens leading to surrounding entryways to their buildings. Unfortunately, these mulches and materials will support combustion and a discarded cigarette butt can cause serious damage. We have been very fortunate though, that the buildings themselves have not been damaged.

Deputy Chief Harry

Olivieri said, "Serious damages and losses can occur if undetected. Peat moss and mulches are combustible, but usually have the characteristics of being a smoldering type fire versus open and visible flame combustion." A cigarette butt buried deep in peat moss or a mulch product can smolder for a very long time before being detected.

Deputy Chief Olivieri strongly promotes the use of properly designed ash trays/containers for the disposal of smoking materials. Ensure they are non-combustible in nature and where possible, douse matches and butts under water before disposing into receptacles other than an ashtray.
