### Stolen Car

Between July 30 and August 1, a 1992 Nissan Z24 was stolen from a Crescent Street residence. The vehicle, valued at \$6,000, was later recovered in Brampton on August 2.

## Barn Fire

Firefighters along with tankers, responded to a barn fire at 9272 Fourth Line just north of 5 Sideroad. A small, unattended bonfire beside the barn, which is in stages of being dismantled, is being blamed for the fire. The remainder of the barn, which was empty of contents, was destroyed. No dollar value has been placed on the structure as it was being demolished. Milton Fire also responded to the scene, but was quickly released after determining the circumstances of the blaze.

Fire crews returned on Friday, July 30 with a report of smoke coming from the remains of the barn fire. After putting another load of water on the debris, demolition crews on site indicated they would be there for the day and would monitor the site for any further problems.

## Car Crash

On Wed., July 28, fire crews responded to a motor vehicle collision between a pickup truck and a car at the intersection of Coles Court and Highway 7, Acton. Occupants were already out of the vehicles upon arrival, but staff assisted EMS with one of the patients. After disabling the vehicles and checking for any further hazards, staff returned to the station.


A bit of a head scratcher as it would seem electronic service would remove the need for costly staff.
