Festive spirit

Along with usual logistical help - handling road closures, insurance needs and communications – Guelph/Eramosa Township Council will give \$4,025 to organizers of this year's Parade of Lights. The Parade is staged by the non-profit Rockwood Farming Community Committee and involves stringing Christmas lights all over farming implements and driving them through the village.

"It's a really important event in our community – the kids love it," Guelph/Eramosa Mayor Chris White said on Friday, adding the Township also supports a Rotary tree planting program and waived rental fees at Rockmosa for a breast cancer fundraiser.

For the Festival of Lights on December 9, some of the items the Township

will handle include getting approval to close Highway 7 and County Road 27, adding the County and Ministry of Transportation to the Township's insurance to cover the event, chairing a traffic control planning meeting, arranging for and installing road closure signs, detour signs, and traffic barricades.

The Township's \$4,025 in-kind donation includes 91.5 employee hours for \$2,406 and equipment for 66.5 hours with a value of \$1,619.

New policy?

Another request by a non-profit group to use Township roads for a charity bicycle ride prompted Guelph/Eramosa Township councillors to decide it may be time for a formal policy.

"We had some push back from parishioners at several churches where it took them half-an-hour to get out of the church parking lot because a bike tour was going by," said Guelph/Eramosa Mayor Chris White, adding they need to develop a policy to deal with the interference.

The issue arose with a request from International Teams Canada for permission to use several Township roads for a charity bike event on October 2. The ride begins and ends at Lakeside Church on Conservation Road in Guelph, and depending on the length of ride chosen, uses several Township roads including Jones Base Line and Wellington Road 38.

Township Council gave permission to use its roads for the Ride for Refuge Bike Tour, which will raise money for the "displaced, vulnerable and exploited."

Warren family files civil suit in daughter's death

The family of Isabel Warren, the 14-year-old Rockwood girl who died when a washroom wall crumbled on her in June of 2009, has filed a \$2.8-million law-suit naming the City of Guelph, two architects and a construction company.


Warren died when a cinder block wall at the South End Community Park collapsed on her during a break in a physed class with her Grade nine class from Bishop Macdonell High School. The statement of claim filed with the Ontario Court of Justice names the City of Guelph, Guelph engineer Larry

Argue and his firm R.J. Burnside and Associates Limited, Guelph architect Lloyd Grinham and his firm L. Alan Grinham Architect and Harrington Construction Ltd.

In a statement of claim, Warren's family claim damages over a "profound and permanent loss of companionship, care and guidance as a result of the death" of Isabel.

None of the claims have been proven in court. In addition to the Warren family's civil suit, the Ministry of Labour charged the City, engineer and architect who will be in court on October 18 for a hearing.
