Youth crime would 'skyrocket' without drop-in centres

Youth drop-in hours and programs in Acton and Georgetown should not be affected by a Town committee decision to give a lot less money than requested to Links2Care, which operates the cen-

If Council today (Thursday) endorses a recommendation from the Community Affairs committee, Links2Care will get \$13,200 from the Town in each of the next two years – a "significant" 10 per cent increase, not the 42 per cent requested.

It costs \$142,000 to run the Acton and Georgetown youth programs, leaving a \$3,426 deficit that Links-2Care's financial director, Mark Spence, said could

be found in other parts of Amanda Kostjuk was their budget, that includes funding from the United Way and Halton Community Investment Fund.

Acton Councillor Mike O'Leary was concerned with the 42 per cent budget increase request, and the proposed fouryear term. He convinced the committee to support a 10 per cent increase, in a two-year deal, laughing at Links2Care's contention that a 42 per cent increase was "slight."

In support of the youth programs, Village Constable Moreen Smith cautioned that "youth crime would skyrocket" without the youth centres, adding a "bored mind is a dangerous mind."

Youth co-ordinator

asked how they balance the needs at the Georgetown drop-in with 13,000 annual visits against Acton, where there are 1,500 annual visits. She said volunteers, including two co-op students, help with the increased demands in Georgetown.

Asked if the youth programming should be part of the Town's mandate and not contracted out. Recreation and Parks director Terry Alyman said the Town's focus is on recreation and leisure, while the youth centres deal with issues including drug use and abuse, sexual activity and social interventions, which require a different set of skills.

After the meeting,

Spence said Links2Care is "quite happy" with the dialogue with the Town and they will "strive to

provide the best service to the youth with the funding that's available." He said the 42 per cent budget

increase would have provided opportunities for more youth programming.
