

HIGHLAND PARK,

HIGHLAND PARK is one hour's ride from Chicago, on the Chicago & Milwaukee Railroad, and is delightfully situated on the high bluffs which at this point rise almost perpendicularly to a height of one hundred feet above Lake Michigan. The grounds are undulating, and traversed with deep, picturesque ravines, which add a charm and diversity to the beauty of the scenery, and afford fine natural drainage, and consequently add to the healthfulness of the place.

PIER.
