BETHANY CHURCH CASE DECIDED.

The Illinois State Supreme Court rendered a final decision in the Bethany church case on Tuesday, May 11, in favor of the majority members, now known as the First United. Evangelical Church, The document is written by Chief Justice Magruder; all the Judges concur in the decision. The document teviews the evidence in the cass, and notes, that when the society purchased the property in 1888, they unanimously voted to exclude the trust clause provi ded by the discipline of the Evangel. ical Association, because they desired to keep sole control over the property. The court says:

"Inasmuch as the property thus belongs to the society or congregation, its ownership will continue in the majority of the congregation when a minority secedes and set up a separate organization. * * *

"We should be inclined to hold, that the decree was erroneous in directing it to be conveyed to the trust ees appointed by the appellees who are in the seceding minority. The record however discloses other facts which make a reversal of the decree becessary, independently of the considerations heretofore advanced."

Bethany church was a legal incorporation, and as such was not a party to the bill. That it is not denied that in incorporating, all the statutory provisions were complied with. That when the incorporation is aftected, "all the property held intenst for the organization shall immediately vest in such corporation and he subject to its control, and may be used mortgaged, sold and conveyed, the same as if it had been conveyed to such corporation by deed."

"It is charged in the bill that the act of incorporating the church was a fraud upon the complainants because they had no notice of it. As the complainants had seceded from the church and organized a separate society, it may be a question whether they were entitled to notice." For the teasons here stated, the decree of the circuit court is reversed, and the cause remanded to that court for further proceeding in accordance with the views herein expressed."

The police magistrate, who occasionally has 2 shillings and 6 pence in his hands, though very rarely, has to file bonds to the extent of \$2,000 for his fidelity in office. At that rate the city clerk should bond in the sum of \$25,000, the collector at least \$100,000 and the treasurer \$1,250,000.
