The firm only made the wheels for the Highwood Cycle company, of which Mr. Blick is manager. The cycle company will now simply get

the same style of wheels made by another manufacturer and will continue to sell its lots on the same scale as before.

The meeting of the board, which was continued from the 13th to the 20th, was finished last. Tuesday. A letter was read from C. E. Loss of the Bluff City Street railroad, and in regard to the bond of the company. The estimates for the coming year were then made, and although the total running expenses of the village were estimated to be about \$4050, counterbalancéd by an income of \$4000 from saloon licenses; still the board, to be on the safe side, made a levy of \$1700, a raise of \$400 on the annual levy of the last six years, which has been \$1300. The board took into account, however, the annexation of the Fort Sheridan sub-division, so that there will not be a large raise in the rate of taxation. A protest was filed by the street and alley committee upon the condition of the sidewalk on the south side of Breakwell's store and the committee was instructed to see Mr. Breakwell and get him to fix the walk, which is in a dangerous condition. The clerk, also, was instructed to post notices that sealed bids would be accepted until the fourth Tuesday in September for a lot of 5 feet 4 inch sidewalk, which was taken from the north side of Washington avenue. The meeting then adjourned.
