

SOLDIER DROWNED.

Last Sunday afternoon about 3:30 o'clock Lieut Daniel Duncan of Co. F, Fourth Infantry, at Fort Sheridan, in company with his brother, Lieut. G. B. Duncan, Adjutant of the post, Robert, son of Col. Hall, and Aubrey, a son of Major R. M. Lippincott, M. D., post surgeon, went in bathing in the lake, all being good swimmers. In a few minutes they were out beyond the second bar an hundred yards from shore, when Lieut. Daniel Duncan was taken with cramps in his stomach, evidently, as he had good use of his legs, coming to the surface many times. His associates made every effort to rescue him, but some way failed to secure a hold, so as to keep him above water, but all in vain; he finally sank to rise no more. Lifeboats were brought, the lake bottom all along the shore was dragged, patrols and lanterns put out, but the body was not found till Tuesday at 12:20 p. m.

He graduated at West Point in 1895 and was 23 years old and very popular among the soldiers and in society also. He was a native of Lexington, Ky., where his remains will be interred.
