Lake county stands well nigh, if not at the head of Illinois fairs in this respect. Every loyal Lake County citizen is proud of his successful county fair. The word "success" is written all over it in letters so big you can read them from any point in the county.

Third: the society believes in 100 cent dollars and no credit. That is it pays all its bills in full and pays promptly. If you win a premium of \$1.50 on the biggest "yaller punkin," you will get a dollar and a half in clean cash every time.

Finally, no one has been known these many years to go away dissatisfied, whether he gets a premium or not. Everything is so fair, honest and above board that all are satisfied. With wheat at \$1.00, corn, oats, potatoes and milk the same, everybody is going to the fair, and we shall go, so as not to have to stay at home alone. You will go, of course.
