

MR. FLINN'S BODY FOUND.

About 8 o'clock this morning some boys, while walking along the beach in Winnetka, found the body of a man near the shore, which was identified as that of Charles Flinn, the second victim of the sad drowning accident which occurred two weeks ago. The body was taken in charge by the officers of Winnetka and the proper officials here notified. The body was fully dressed, except for the coat, which he had probably thrown off in his hopeless fight for life. In his pockets were found a railroad ticket with his name written on it, a dairy and a few papers; a gold ring on his finger, which he usually wore. This explodes the theory advanced by many that the boys were robbed while out on the lake and then made to swim for it. Undertaker Prior drove down soon after being notified and reached here with the body just afternoon. Owing to the lateness of the hour the NEWS could not learn of what funeral arrangements would be made. A full report of the obsequies will be given in next week's issue.

FOOT BALL.

The Academy boys were defeated in their first regular game with Lake Forest, Wednesday. They were far out-weighted by the Academy and Varsity men, but put a very plucky game. The Lake Forests won the toss giving the cadets the kick off. Sine again kicked off and after first down it was returned on a punt to Cadets' 15-yard line. After three trials it was punted to Forests' 30-yard line, fumbled and secured by the Cadets. It was again punted to within a yard of Forest's goal and here time was called.

The features of the game was the tackling of Matteson, Rice, Lomax and Engles, and punting of Sine.

The bucks of the Forests' did very creditable line backing and if our Varsity can get a line in proportion to their backs ought to put a good team on the field.

The Baptists give their pastor Rev. W. M. Vines, a reception tomorrow evening at the residence of Robert G. Evans.

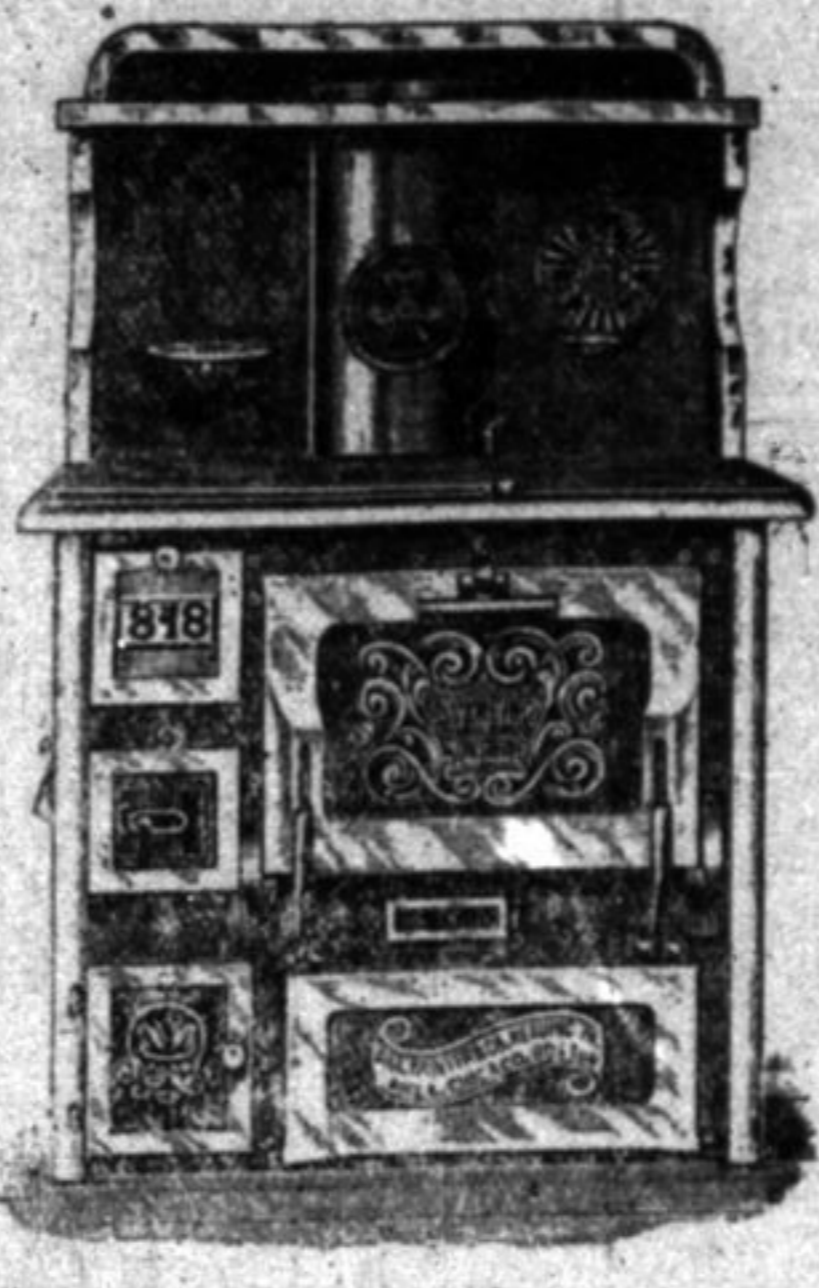
J. McGregor Adams and son-in-law, Mr. Barry, this week returned to Chicago, where they will put in the winter.
