

HON. R. G. EVANS.

The present mayor of Highland Park, Robert G. Evans, has been a resident of this town since 1873, and may properly be classed as one of our leading and most successful pioneers and citizens. Immediately upon locating here Mr. Evans entered mercantile pursuits. He met with unqualified success and soon branched out into the extensive manufacture of brick, first at Highland Park and later at Fort Sheridan and Evanston, also. Mr. Evans is a very large property owner in Highland Park and vicinity. He has always taken an active and representative part in all public affairs designed to better the standing and government of his home town. Mr. Evans has served three terms each as alderman, public school trustee and township school trustee. He is now serving his second term as mayor of our city, having been elected the last time without opposition. He is ever an active exponent of honorable political methods and straightforward municipal and public administration, and his liberality, efforts and influence have had a marked effect upon the wholesome growth of the North Shore.

JOHN FINNEY.

The younger generation of Highland park have in the career of Mr. John Finney, our city clerk, a stimulating and honorable example of a public officer and a true American citizen. Mr. Finney was born at Lockport, Niagara county, N. Y., in 1844. He came west in the year of 1852, where he received his education. While attending a business college in Waukegan in 1862 he decided to enlist. On March 10 of that year, at the age of 16, he enlisted in the Sixty-fifth Illinois volunteer infantry. Mr. Finney saw active service during the war. He was at the battle of Harper's Ferry, Va., where he was taken prisoner and paroled. He was in the engagement at Knoxville, Tenn., and, in fact, was all through the Atlantic campaign. He was also at the battles of Columbia, Franklin and Nashville, Tenn., and in the battles of Fort Fisher and Fort Anderson, N. C., closing the campaign at Raleigh, N. C. After serving three years and six months Mr. Finney was mustered out the 26th of July, 1865, as sergeant of his company. Mr. Finney can look back with pardonable pride upon his war record. There are few men, like him, who entered the army at the age of 16 and served with distinction and honor throughout the war, being mustered out before reaching their majority. After the war Mr. Finney returned to Lake county and entered into contracting in mason and plaster work. His health failing him, he entered politics, being elected alderman of Highland Park, a position he held for two terms. In 1880 he was elected city clerk, a position he has held with
