The council met at 8 and adjourned a little past 10 o'clock, Tuesday evening. The records showed that bills were audited to the amount of \$1629.28 for October. A letter from E. L. Hambleton, was read accompanied by the new plat of the Ex-- wear addition, which was referred to the street and alley committee. The fire and water committee reported that they had expended about \$16. on repairs at pumping station, and they bad no recommendations to make as to R. G. Evans for a rebate of some \$18.00 he had on an old rate water bill. Mrs. Edgar M. Snow's request to replace the short cedar posts at the ends of the Central parkway in front of her residence, with ornamental iron posts, was after quite an extended discussion, grantea.

Then came up the petition or protest of Fred Denman, Daniel Collins H. J. Olsen and John Genest, over Alderman Obee's contract with H. Ewart for the three snow plows at \$15.00 each, while they would have built them for \$11. and \$12. each. Messrs. Obee and Phillips said a year ago they asked for bids and \$15.00 was the lowest figure, and afterwards they had to pay \$3.00 extra for wings and Mr. Obee said he thought he was saving the city \$9.00 on the job, while Col. Davidson said if they had called for bids the city would have got four snow plows and had one dollar left, for its \$45.00. Mr. Phillips said he supposed snow plows would cost as much this year as last while Col. Davidson said he got bids on the Academy supplies every three months, but he supposed Mr. Obee had secured bids or prices from the other blacksmiths when he approved Mr. Ewart's contract.

Messrs. Comstock, et al, came in with a petition for a new sidewalk in front of lots 27 and 32 South Highland, on Judson avenue, to connect two strips of walk already built, and so give them one continuous walk. Referred.
