Being thirsty during the night Mc-Pherson arose from his bunk and tip-toed down to the basement, where drinking water was kept cool. dim light burned within the stone apartment. In its faint flicker he saw a wild-eyed man crouching in the corner near the water barrel. McPherson paid no attention to him, but advanced toward the water barrel. The maniac, without warning, suddenly sprang upon him and slashed violently at his face with a razor. McPherson fought his assailant, who only struggled harder and cut deep gashes in both his wrists McPherson finally broke away and and kicked his foe into a corner. Then upon examining himself he found more than a dozen deep cuts in body and wrists and shoulders; in fact he was a mass of cuts and mangled flesh and blood.

McPherson dragged himself upstairs, awoke two of his friends and begged to be taken to the hospital. Horrified, they complied, and then called for the guard. The night guard with Lieut. Saxton, the officer in command, quickly responded. The officer sped to E Company's barracks, routed out First Sergeant Benzinger and together they plunged into the room full of sleepers and in less than a minute every man was awake. Only. one did not sit up in bed. The sheets and blankets were jerked off the shivering form, revealing a pair of bloody hands and a torn and bloody shirt. The man was still dressed and wore his shoes. Tne razor was found in the man's haversack. He was put under a strong guard, marched to the guard house and locked up.

O'Neill is a recent recruit, he having enlisted in Philadelphia, Dec. 27 last. He is 26 years old and was. formerly a laborer. He gave no reason for attacking McPherson.

McPherson was one of the regimental cooks and his home is in Jackson County, Iowa. He said yesterday in the hospital:"I think I will get well; but I am very sorry it happened, because it will prevent my going to Manila with the boys. I don't know what that man went at

Major Adair, the post surgeon, said that there was a chance for Me-Pherson's recovery, although he is in a very dangerous condition.
