Trustee Dingwell reported a leaking hydrant in front of Mrs. Hawkes' lot and moved that the water works engineer be instructed to repair it. Passed.

Trustee Herdman reported that a water main in Ash street had burst and that 43 service pipes, all in macadamized streets, had been frozen; also that the Glencoe meters are not working satisfactorily and that by test there was loss of . Ice Cream and Sherbets. from 25 to 40 per cent and on his motion the clerk was directed to notify the Glencoe council of the loss and ask for a committee to meet the committee on water and see the test of the meters and arrange for prorating the loss.

The attorney reported that it was not necessary to pass an ordinance directing the collector to turn in a delinquent list, as the statutes required it.
