To the President and Board of Directors of the Village of Winnetka,

Winnetka, Ill:

Gentlemen: We beg to advise you that we are unable to purchase a 46-foot strip through block 64, adjoining the easterly right-of-way of the C. & N. W. R. R. Co., from Maple street to Willow street, at a price that we consider within reason, and are therefore now compelled to commence condemnation proceedings for the purpose of acquiring our right-of-way through that block 42 feet wide, in accordance with the conditions of our franchise.

It will, therefore, be impossible for us to accept the proposition made us by your committee of the whole, which provides for acquiring a 46-foot right-of-way through that block. We are, however, ready and willing to accept all the other conditions of your proposition, which are as follows, viz: (1) In place of a grade crossing over Willow street, as now proposed, we agree to construct a substantial viaduct.

(2) We agree to construct and maintain a station on our line just north of Maple street, as indicated on the plans we have submitted to you.

(3) We will purchase or condemn a strip of land 66 feet in width from the south termination of Wilson street to the south line of the village of Winnetka, and dedicate the east 32 feet thereof to the village of Winnetka for street purposes. As we are now leting our contracts for the completion of our road to Evanston, it is necessary that this matter should be decided at once so that in case a viaduct is decided upon, we can place the contracts for the steel structure at once so as to have it in readiness, and this will also necessitate the extension of time for the completion of our road through your village to July 1st.

Another subject which demands immediate attention is that your honorable body appoint an engineer to prepare the specifications for the necessary street improvements as required by Section 4 of the ordinance granted to Bluff City Street, Electric Railway Company, as we are obliged to let the contract for these improvements at once in order to have the same completed within the time specified in the ordinance. Railroad company to pay engineer.
