Meeting April 4. All present. Minutes of previous meeting approved. Presentation of petition of the Chicago & Milwaukee Electric Railway Co., asking franchise to construct double tracks upon Railway avenue; also petition of property owners representing the frontage on the line of roati contemplated. Accompanying said petitions the railway company submitted an ordinance for consideration of the council. The petition of the property owners was referred to the city attorney and clerk for verification, and the matter of the ordinance was referred to committee of the whole, with the mayor to preside, and publicity to be given through the News-Letter of the time said meeting will be held. Petition of the legal voters of Ravinia requesting the annexation of all that portion of land south of the city limits and east of the railroad right-of-way south to the Cook county line become a part of the city of Highland Park. Referred to finance committee to report thereon at next regular meeting. Petition of property owners representing the frontage on Dean avenue requesting the council to order a six-inch water main to be laid on said avenue. Referred to fire and water committee with power to act. Report of Board of Health on the condition of the city water supply was read and referred to the fire and water committee. The report of the fire and water committee on the petition of the Gray Electric Company, asking for a special low rate for water used for manufacturing purposes, was referred to finance committee. The report of the fire and water committee on sundry cases where service pipes were frozen between the water main and service box; commitexpense of services rendered in thawtee recommended that the city pay the ing out the service pipes in such cases. Approved. Regarding claims for rebate on account of leakage council ordered claims be allowed. The proposition of A. W. Fletcher to purchase the city transit for prov cash was received and referred to the finance committee with

power to act. A resolution was passed providing for improving two roads running north and south through the city for bicyclists. It contemplated buying a scraper to scrape a path three feet wide. Partial report from special committee on the tramp nuisance was considered. A full consideration of the problem will be reviewed at next regular meeting. Bills favorably passed upon in the sum of \$485.76 were returned by auditing committee and council directed the clerk to draw on the treasurer in favor of claimants. Monthly requisition for supplies for the several departments were favorably acted upon, and the clerk was authorized to make the purchases. Adjourned.
