GLENCOE COUNCIL.

The old council held its last meeting at the regular hour Tuesday evening. The election had been held in the council chamber, but was out of the way a little after seven. Meanwhile a conference was in progress in the clerk's office between the councilmen and officers of the C. & M. electric railway. The specifications for the macadamizing of Green Bay road had been prepared by the village engineer, Mr. Windes of Winnetka, and the railway people had been asking a small addition to the width of the right of way granted them on Green Bay road. The councilmen were disposed to give them what they asked if they would, as a consideration, do certain things in addition to what was required in the franchise. But up to this time no agreement had been reached on which an amendatory ordinance could be formulated, and the conference Tuesday evening resulted, as the preceding ones had, in no result.

The old council went through the usual routine. A petition to relieve Central avenue of the pond a little east of the Green Bay road was sent to the street committee with power to do what was necessary to effect the object.

Bills were read and ordered paid aggregating \$365.00.

Treasurer's report showed balances April 1st as follows: general \$2439.81; water, 321.58; rebate, 570.15; frontage, 116.88; spl. 116, 2048.67; spl. 129, 1474.77; spl. 135, 132.71; spl. 136, 132.36.

The clerk's report for March showed cash receipts \$433.20, of which \$229.14 was for water and \$196.06 for Vernon avenue improvement.

A few committee reports finished up the evening's business and then the election returns were opened and canvassed. They showed the vote at the village election held during the day to be as follows: For president, Markham B. Orde, 129; James F. Dennis, 77; for councilmen: George

Park, 123, T. C. King, 117, J. K. Calhoun, 116, J. B. Meaney, 88, S. Newhall, 122, John J. Flanders 94, Oscar Poole, 105, John Fanning, 86, W. Rankin, 36, L. H. Lloyd, 97; for collector: A. G. Ligare, 131, J. Beck, 48; for street commissioner: George Diettrich, 114, J. Tennis, 64, Henry Witt, 17, Paul Brandt, 8; for marshal: August Brandt, 129, John Matthews, 64; For police constable: John Maloney, 136.

So the council declared the elect to be as follows: President Orde; Councilmen Park, King, Calhoun, Newhall and Poole; Collector Ligare, Street commissioner Dietrich; Marshal Brandt; police constable Maloney.

The old council having finished its work adjourned and the new president and members came within the bar and were sworn in by Notary Morton T. Culver. Order having been secured, ex-President Day escorted President Orde to the chair and introduced him to the council and to the large crowd assembled in the lobby, by whom he was received with a very flattering round of applause. President Orde before assuming the chair made a neat little address expressing his sense of the dignity that had been conferred on him by the good people of Glencoe, and of the obligation it imposed on him to do the best he could for their interests. He referred to the superior qualifications of his two predecessors, who were not only very capable business men but lawyers and asked that allowance might be made for any short-comings of his own in comparison with the valuable services rendered by them.

Ex-President Day concluded the remarks with a graceful little farewell speech and then the new council settled down to answer to the roll call.

It was agreed that an adjourned meeting be held the following Friday evening, and then the council adjourned.
