for several years been attorney for the Winnetka board of education; Mr. Jay has served on the Wilmette board of education, and Mr. Nauzig is now president of the Gross Point school board, but will resign when elected to the township board. We do not know whether Mr. Cheney has served as a school officer, but are reliably informed that he is a public spirited gentleman, deeply interested in educational matters. There should be a full vote.

Board of education meeting May 1st. Ordered balance of \$255. paid Mr. Flanders for services as architect. Awarded repairing of steam heating to G. D. Spear for \$168, and of blackboards to Standard school Furnishing Co., for \$65. Appointed F. C. Todd working superintendent of repair work. Voted to retain all present teachers for coming school year at present salaries except Miss Day, who was given an increase of \$2.50 per month. Fixed closing exercises of school for evening of June 22nd, in new school house.

Contractors have agreed to have repairs completed by June 1st.

The labor famine has delayed work on the school house grounds.

#### GLENCOE COUNCIL.

Regular monthly meeting May 2d. President Orde in the chair, and all members being present.

Letter from R. D. Coy, asking that culvert in Greenleaf Avenue in front of his property be filled and extended. Referred to Street and Alley Committee.

Mr. Poole presented tax receipts of L. J. Norton for payment on water assessment, who claims interest collected on two installments was erroneous and excessive. Referred to Committee on Taxes and Assessments.

Bills were read and payment ordered aggregating \$740.63. Of this amount \$275 was for a carload of lumber, \$94 for work employed on streets, \$26 for a carload of slag, and \$38 for water meters.

The Treasurer's report showed a balance at the end of April aggregating \$6,530.

receipts during April to have been \$179.23.

On statement by the Clerk that only three Sheridan Road Warrants for \$1,000 each remained outstanding, that notice had been given to take up one and there was nearly enough balance to call in a second, Mr. Calhoun moved that the remaining two be called in and the Treasurer be authorized to borrow temporarily from other funds what may be necessary to redeem them at once. The proposition was agreed to.

The Street Commissioner reported sidewalk on west side of Greenleaf between walks of Mr. Schnur and Mr. Coy 198 feet built and paid for except about five feet. He reported following walks in a condition needing renewal: From postoffice corner to Greenwood on north side of Park Avenue; from same corner to Lincoln on west side of Vernon, and at Greenleaf and Downing in front of property of Franklin Newhall. Consideration of these walks referred to Street and Alley Committee.

The Street Commissioner reported that the owner of the gravel pit at Gross Point from which village supplies had been obtained had raised the price from 15 to 30 cents per cubic yard and would not agree to let the village have more than thirty yards more. The Street and Alley Committee was authorized to do what they found necessary to procure a supply.

The bond of August Brandt as marshal was reported back adversely by the Finance and Judiciary Committee, who thought the sureties insufficient. Report adopted.

The Committee on Streets and Alleys were authorized to engage a steam roller (which is to be employed at the golf grounds) to do the necessary rolling of the slag in completing work on Vernon Avenue near South. A refund of \$6.50 to George Topper of Chicago for fifth installment of water assessment paid in Block 26, Taylor's Addition, was ordered.

Mr. King moved that the Clerk notify Vice President Frost of the Chicago & Milwaukee Electric Railway Co. that on receipt of his check The Clerk's monthly report showed for \$500 the Council would assume

the settlement with Thos. H. Murdow for additional street room on the Green Bay Road frontage of his property and grant the company the additional four feet width of rightof-way asked for, contingent on the company's acceptance of the plans and specifications as prepared by the Village Engineer and previously accepted in letter of President Ball.

Mr. Park moved to amend by making the amount of the check \$2,000 instead of \$500, and the amendment prevailed, and Mr. King's motion thus amended was adopted. The vote adopting the amendment, and that also on the adoption of the amended motion, was as follows: Ayes-Calhoun, Newhall and Park. Noes-King and Pool.

Messrs. Cing and Parks of the Finance and Judiciary Committee were directed to audit the Treasurer's account.

The President re-appointed Fred F. Lane to be janitor of the Village Hall, and the appointment was confirmed.

The Street Commissioner was authorized during May to pay \$4 a day for teams and \$1.75 for laborers, he having stated they could not be obtained for less.

The Council then adjourned, subject to call.
