WINNETKA COUNCIL.

A regular meeting of the village council of the village of Winnetka was held May 2, 1899. Present: President, F. E. Herdman, Trustees H. A. de Windt, W. H. Curran, Geo. Baker, A. B. Capron, J. C. Winship.

The minutes of the previous meeting were read, and were approved with the following corrections, viz: Trustee de Windt's statement in regard to a sidewalk in front of the property owned by the Bank of Montreal was changed to say that it had been reported to him that such a walk was needed; also that the collection of the dog tax was to be made by the village collector, and also that the president was to be a member of the committee to confer with the committee from the village of Glencoe in regard to the loss of water through the meters.

On motion of Trustee Baker, seconded by Trustee Winship, and which was carried unanimously, smoking was prohibited in the council room during the meetings of the council.

Bills were then read as approved by the committee on finance, and on motion of Trustee Baker, seconded by Trustee Winship, the president and clerk were directed to issue warrants for the same. Carried.

On motion of Trustee Curran, seconded by Trustee Winship, the village attorney was requested to take his proper position in the room.

On motion of Trustee Winship, seconded by Trustee Baker, a meeting of the council was called for next Tuesday evening (as a committee of the whole) to consider the liquidation of the village bonds.

On motion of Trustee Capron, seconded by Trustee de Windt, the following ordinance was passed, viz; The council of the village of Winnetka do ordain: That section 3 of chapter 24 of the municipal code of the village of Winnetka, approved by the village council of the village of Winnetka May 22, 1893, and repealed by the said village council April 28, 1896, be and the same is hereby re-enacted and shall hereafter be a part of the municipal code and be a valid ordinance of the village of Winnetka.

The following motion was made by Trustee Winship, and was passed unanimously; "I move that Charles C. Arnold, at his own expense, be allowed to improve the street on the sonth of his property and running from Baldwin Place to Sheridan Road, with a 15-foot roadway of slag and gravel of 10-inch thickness in the center and an 8-inch thickness
