BE IT ORDAINED by the City Council of the City of Highland Park.

Section 1. That the following sums, or so much thereof as may be authorized by law, be and the same are hereby appropriated for corporate purposes for the fiscal year commencing May 1st, 1899, and ending April 30th, 1900:

Forconsteucting, repairing and maintaining streets and bridges...... 1,950.00

SEWERS.

For constructing, repairing and maintaining sewers.....

For street lighting one year...... 3,025.00
PRINTING AND STATIONERY.
For printing and stationery purposes 100.00

For Fire Department purposes..... 300.00

BOND AND INTEREST.

For bonded indebtedness and interest falling due..... 1,875.00

For miscellaneous corporate purposes not hereinabove enumerated 2,166.00

Section 2. All unexpended balances of any item or items of any general appropriation made by this Ordinance may be expended in making up any deficiency in any item or items in the same general appropriation and for the same general purpose or in a like appropriation made by this Ordinance.

Section 8. All Ordinances or parts of Ordinances inconsistent herewith shall be and the same are hereby repealed.

Section 4. This Ordinance shall be in force from and after its passage, approval and publication.
