TO LOCATE SCHOOL SITE.

A public meeting to discuss the location of site for a township high school was held at the village hall, Winnetka, July 20th, 1899.

The meeting was called to order by Mr. F. E. Herdman, who was made chairman. J. C. Burkitt was chosen secretary.

Gen. Howard of Glencoe, one of the high school trustees, addressed the meeting in favor of a site on Winnetka avenue, east of the railway tracks. He submitted a letter from A. C. Frost, vice-president of

the Chicago & Milwaukee electric railway, offering a 4-cent fare for teachers and scholars from any point on their road within the township if this site is selected, also to build a suitable station.

Remarks were made upon this offer by the chairman and S. W. Osgood.

S. W. Osgood referred to consent from Mr. Temple to assessments for sewer connections, etc., and sidewalk.

A letter from Joseph Sears of the Kenilworth company was submitted offering to join the frontage owners of Winnetka avenue in grading, draining and macadamizing; also to open a street from Kenilworth, connecting at a convenient point with said avenue.

Gen. Howard stated that he was assured by the frontage owners of Winnetka avenue that they would agree to putting in water.

S. W. Osgood subsequently addressed the meeting more fully in favor of this site and opposed a site at Gross Point.

S. W. Osgood moved the appointment by the chairman of a committee of five, but upon an amendment offered by E. W. Osgood, and accepted, the number was made fifteen to co-operate with committees in the other villages in securing the adoption of this site.

F. E. Herdman was appointed chairman of the education committee.

The prices quoted for three different sites offered were as follows: Five acres at Gross Point, \$15,000; Six acres on Winnetka avenue, \$14,500; Site below Garland place, per acre \$3,000.
