COUNCIL MEETINGS.

The president called a special meeting of the council of Winnetka on the evening of Aug. 8th. President Herdman, Trustees Baker, Capron, Curran, de Windt and Winship were present.

The president read ordinance for committing prisoners to House of Correction, Chicago, and on motion of Trustee Winship the same was passed on unanimous roll call.

On motion of Trustee Winship the following was ordered addressed to the county treasurer: "The county treasurer of Cook county, Illinois, is hereby authorized and instructed to separate the special assessment No. 78 of the village of Winnetka for macadamizing Elm street on the north half of block 27 of Peck's sub division in said village and allow the owners of the west 193 feet thereof to pay their proportion thereof and allow the balance of said assessment to stand against the east 181 feet of said block."

On motion the meeting was adjourned.

A special meeting of the council of the village of Winnetka, called by the president, was held August 15th. Present President Herdman; Trustees Baker, Capron, Curran, de Windt, and Winship.

The minutes of last meeting were read and approved.

The President stated object of the meeting was to consider various sections in the ordinance granting franchise to the Bluff City Electric railway co, and its successors, and to see to the faithful execution of the same.

On motion of Trustee Capron the regular order of business was suspended.

The president read the ordinance referred to and remarked upon the danger of trains crossing streets without the ringing of gong.

The disposition of the 24 incan-

descent lights of 32 candle power that the electric railway co, are to place at the crossings of their line was deferred.

The section regarding 5 c. fare through Winnetka and to Glencoe and to Wilmette and its present fulfillment, or otherwise, was discussed.

The section regarding the sale of tickets to Davis street, Evanston, received attention; also the condition that 20 ride tickets should be sold on the cars.

The president called attention to condition of trestle work at and near Willow street and on motion of Trustee de Windt the following resolution was passed:

"Whereas, by an ammended ordinance, passed by the village council, March 7th, 1899, the Bluff City electric railway co., and its successors was authorized to construct a superstructure on the west 20 feet of their right-of-way between Maple street and Willow street to such a point that would make a grade of one per cent on said trestle work; and, whereas, said superstructure has been extended by said company without authority on the public highway east of the right-of-way of said company, five feet more or less; - now, therefore, the president of the village of Winnetka is hereby instructed to notify said railway co, to remove such obstructions within ten days from the public streets whereon said superstructure has been constructed by said company where the same extends more than twenty feet east of the west line of the right-of-way of said company."

Trustee de Windt remarke d upon a letter from Engineer Windes regarding drainage of low spot near Locust and Spruce streets. Referred to drainage committee.

On motion the meeting was adjourned.
