Treasurer's report showed a balance on hand of \$22,102.83.

Village Clerk's report showed funds turned over to treasurer for Sept. \$1,462.90, principal from water consumption.

Village workman's report showed cost of cleaning catch basin, etc, \$253.97. Ditching in Ash, Oak, Birch and Locust streets \$163.05, New crossings and repairs; repairing and graveling road at water tower, repairing hydrants, etc, \$55.60.

An ordinance regarding fenders and wheel guards on street cars was passed on motion of Trustee Winship, seconded by Trustee Capron.

SPECIAL COMMITTEES.

Trustee Winship reported excessive assessment on lot 4, block 7, Gage's sub, and moved refund of 4th installment, this was seconded by Trustee Curran and passed.

Trustee Winship moved, seconded by Trustee de Windt, that

the room in village hall formerly used for kindergarten in connection with public school be rented for private kindergarten to Miss Capron for \$3.00 per month. Passed.

MISSOELLANEOUS BUSINESS.

President spoke of ordinance requiring ringing of gong, slowing down and stopping at certain streets of street cars. After discussion it was moved by Trustee Baker, seconded by Trustee Curran. That the matter be referred to Committee on Judiciary to draft such an ordinance. Passed.

Bids for cement walk on part of North avenue, referred to Committee on Streets with power to act after Oct. 15th.

The meeting was then adjourned.
