GLENCOE COUNCIL.

Regular meeting Tuesday evening 3d inst. All present except Newhall.

George Park was granted renewal of license as plumber.

A protest of R. D. Coy against proposition to compel owners of abutting property to build a cement sidewalk on the westerly side of Sheridan road from Hawthorne to South avenue was read and filed.

Application of Miss Helen Hinsdale for rent for hall for a dancing class was read and referred.

James Cape & Sons asked extension of 30 days for completion of their Green Bay Road contract. Declined except by consent of all parties interested.

Vice President Frost of the C. & M. E. railway sent letter agreeing to pay \$100 more towards settlement with T. H. Murdow whereby the railway company should be allowed room to correct their curve just north of Central avenue according to plan prepared by their engineer. The plan did not accompany letter, so action was deferred till this should be obtained.

A letter from T. H. Murdow proposed to accept \$200 for a line that would give the village the small triangle now outside his fence and ask-

ing that the corresponding triangle inside his fence be vacated by the village. Action deferred to await information from the C. & M. E. Ry. Co. referred to above.

Engineer Windes sent in report of work on Green Bay road and estimates in favor of contractors Cape and Porter. Amount now due Cape \$5056.98, for which warrant was ordered. Amount due Porter on final estimate \$608.41 and \$100 for tile laid on Northwestern grounds between Park and Hazel. Porter's claims referred to committee on street and alleys.

Routine bills read and ordered paid to amount of \$563.50.

Chairman King, from the finance committee reported \$4000 4 per cent subway bonds sold to N. W. Harris & Co., Chicago at par and accrued interest; bonds delivered and check received and turned in to treasurer.

Clerk was directed to buy from Messrs. Cape a car-load of medium broken stone for top-dressing Sheridan road and Vernon avenue.

Chairman Calhoun, from S. & A. committee, proposed that street commissioner connect with catch-basin house drain on northerly side of West Hazel now discharging into street gutter, but did not meet with a second. This brought on discussion of the question of permitting connections with the subway sewer, which was ended by the adoption of a resolution offered by Park requesting the engineer to prepare a plan for an extension of the subway sewer, from Greenleaf avenue down Hazel avenue to the lake, as a main outlet sewer.

On motion of King, the attorney was instructed to prepare a paper for signature of property owners who desire to drain into the subway sewer.

On motion of Calhoun he was instructed to prepare an ordinance for cement sidewalk on westerly side of Sheridan Road from the north line of 'C. L. Day's lot to the south line of Hawthorn avenue.

On motion of Poole, he was further instructed to draw an ordinance providing that none but 'cement walks shall in future be laid on Sheridan road.
