The general subject of the lectures will be "Studies in Fiction," under the heads of: Oct. 24, (1) Stories in Art and Life. Nov. 7, (2) The element of Plot in Stories. Nov. 21, (3) Character Drawing in Stories. Dec. 5, (4) Narration, Description, Dialogue and Author's Comment. Dec. 19, (5) The Romance and the Novel. Jan. 2, (6) The Functions of Fiction. A syllabus of the course, containing an outline of each lecture, for the convenience of those desiring to read in advance, can be had at any time from the steward of the club house on payment of ten cents. These lectures are open to all club members free, and to those who are not members of the club, two dollars for each person for the entire six lectures.
