

expense; though he shows how filtration or septic tanks for the sewage can be constructed on the village beach, if thought best, without being offensive or objectionable in that locality. He suggests the natural division of the village into four drainage districts, the first of which would be the one served by the Hazel avenue sewer. He accompanies his report with a map showing that the Hazel outlet will drain as far west as Grove street, as far south as Washington, as far north as the Green Bay road Beinlich's and the north end of Downing avenue. He advises what is called the "separate" system, as against the "combined." The village has naturally such good surface drainage that it is not necessary to throw the storm water into the same sewers as the house drainage, and that it is never desirable to do this anyhow for reasons which he gives. He estimates District No. 1 as shown on his map can be thus sewered for a cost of \$1.30 per linear foot of sewer, or 65 cents per front foot on each side at present high cost of materials.

The council agreed to meet informally Friday night to go over the report. Councilmen seem to think Mr. Windes' ideas the most practical yet presented on the subject, while all agreed that his report was deeply interesting as a general study of the subject.

Routine bills were ordered paid to amount of \$738.74; also bill for water taken from Winnetka for six months ending Oct. 1st, \$642.70.

Clerk reported month's payments to treasurer \$56.38; and street commissioner reported payments into treasury since last report \$211.57, of which \$129.30 was received from Contractor Cape for sand taken from village beach, balance being for lumber sold.

Street commissioner was authorized to purchase from Mr. Cape some 6000 feet of 3 inch plank suitable for crossings, which was offered at \$12 per thousand; and the chairman of the street and alley committee was authorized to procure a ladder for the lamplighter.

Mr. Park offered a resolution to authorize the attorney to negotiate

with Thos. H. Murdow for additional ground along his Green Bay road frontage (about 640 square feet) required to make the street line uniform with the rest of the street, at a price not to exceed \$2500 an acre, the cost being about \$37.30; with the alternative for Mr. Murdow that if this offer was not accepted the attorney would institute condemnation proceedings for the village. The vote on the resolution stood: Messrs Newhall and Park for and Messrs. King and Calhoun against. The tie was decided in the negative by the chair and the resolution lost.

Claim of Dr. John Nutt for refund of \$8.19, duplication of assessment on some lots near the skokie for the first installment of the water-pipe assessment. Referred. Adjourned.
