SPECIAL ASSESSMENT NOTICE.

Notice is hereby given to all persons interested that the city council of the city of Highland Park having ordered that a sewer be constructed in and along the center line of Central avenue from a point 125 feet westerly of the westerly line of Green street to the westerly limits of said city and in and along the center line of McGovern street from the center line of Central avenue southeasterly to a point 400 feet from the southerly line of said Central avenue.

That the said sewers shall be constructed of the best quality of salt glazed vitrified socket sewer pipe, laid to a true line and grade in trenches excavated through said streets on lines above described.

The sewer in McGovern street shall be laid with its gradient starting with its connection with the Central avenue sewer at 98.5 feet above city datum, and shall rise from thence to 103.8 feet above city datum at a point 50 feet southerly of the southerly line of Central avenue. From thence the gradient shall rise on a 6-100 percent grade to its southern terminus.

The ordinance for the same being on file in the office of the city clerk have applied to the county court of Lake county for an assessment of the cost of said improvement according to benefits; and an assessment thereof having been made and returned to said court, the final hearing thereon will be had at the December term of said court, commencing on the 4th day of December, A. D., 1899. All persons desiring may then and there appear and make their defense.
