That surely would be creditable to his sagacity and true regard for the city's best interests.

Candidate Stearns has our sympa thy in the unfortunate predicament in which the way the party caucus here was run has placed him before the citizens of Highland Park. We shall be loath to believe he or his agent here suggested or encouraged any such action, for it was the Tammany kind of politics, which all honest men abominate - republicans as well as democraty.
