A regular meeting of the council was held Feb. 27, 1900.

Present, President F. E. Herdman, Trustees Geo. Baker, A. B. Capron, W. H. Curran.

The minutes of the last regular meeting, Feb. 6, and the adjourned meeting of same, Feb. 13, were read and approved.

Two letters from Northern Trust Co. were submitted regarding bond now paid by treasurer. A letter from Trustee De Windt regarding presentation made to him on behalf of the board of education, regarding repairs made on old school building. On motion of Trustee Capron, seconded by Trustee Curran, this was left to the President. Another letter from Trustee de Windt regarding bonds held by Trowbridge, McDonald & Norton on motion of Trustee Baker, seconded by Trustee Curran, the clerk was instructed to write said firm and send copy to Mr. de Windt. Another letter from Trustee de Windt conveying request of Joseph Sears of the Kenilworth Co. for some changes in the text of contract. It was decided to maintain the rates stated. A letter was submitted from Geo. F. Orde, suggesting the consideration of some plan whereby from six to ten residences in Glencoe might be supplied with electric light from the Winnetka plant. This was allowed to go over for future consideration, as it is the desire to first supply all Winnetka residences so desiring.

A motion was passed to notify the treasurer to make some corrections in detail; also for collector to make

up delinquent list of special assessments.

A letter was read from F. W. Wheeler regarding leakage of water pipe on his premises. The clerk was instructed to disavow responsibility of village for leakage in private pipes.

Another letter from same was read regarding sewer at south limits.

There was a discussion regarding the present method of taxation.

The meeting was then adjourned.
