with electric light constructions until regular meeting, April 3, 1900.

No reports from other committees. Village Treasurer's report was submitted, showing a balance of \$4,764.95, of which \$1,848.64 is general fund.

On motion of Trustee Capron, seconded by Trustee Baker, the president was authorized to have streets and sidewalks cleaned so that water may run off freely. Adjourned.
