A Statement.

Unintentionally the writer did Charles B. Rice an injustice last week in classing him as a member of the political "gang," to use a current phrase of the street, and criticizing him for being affiliated with them. Neither they nor we could understand, save on the grounds indicated, why he should allow the use of his name on that town ticket unless he affiliated with the men who made it up and composed it. We were told he was out of town the day his name was put on, but that he returned the next day, and still his name stood there. When he refused to run for supervisor a year ago not a few said it was because he did not wish to break with the Obee crowd.

Now his immediate, absolute, and peremptory withdrawal from that ticket, as soon as he reached home, shows that our conclusions and criticisms were incorrect and uncalled for, though made in all honesty and sincerity. We make this statement just as cheerfully as we made the criticism, as it was a personal disap. pointment, as in the case of Mr. E.A. Small, that such a man, one with such a recognized position, standing and character should injure himself and forfeit so much for the sake of any thing to be gained by an alliance with men and methods whom the good people of Deerfield township and the city of Highland Park utterly repudiate.
