While Mr. Aldridge was discussing his arrest with Judge Dooley, City Marshal Thomas M. Dooley walked behind him and struck him on his face and side of his head two or three hard blows with his fist or his "billy," for his face was black and blue when we saw it three days later. Constable Grant and several others, including Mayor Cobb, were standing in the court room or in the front store room. Later he was taken in hand by Mr. Grant to Judge Holmes, where he acknowledged the deed and was fined \$3.00 and costs.  
Mr. Aldridge is competent to take care of himself in this matter, but what we want to know is, how long this city is to be disgraced with this kind of official bullying and rowdism? It is only a few weeks since this same city marshal found a man standing quietly on the steps of his boarding house and struck him one or two blows with his "billy" without cause. There is no necessity for such an official; we have plenty of good men for marshal and men whom the good people of the Park would like to have in that position. Why need the mayor disgrace the city and menace decent, orderly people by keeping such men in office? The marshal should be discharged at once.

**Special Assessment Notice.**

Notice is hereby given to all persons interested, that the city council of the city of Highland Park in the county of Lake, state of Illinois, having ordered the curbing, grading, draining, macadamizing, constructing retaining walls, brick cross walks, and otherwise improving Sheridan Road from the northerly line of Central avenue to the north line of Broadway avenue (except said court in the city of Highland Park, county of Lake, State of Illinois).  
The ordinance for the same being on file in the office of the city clerk, have applied to the county court of Lake county for an assessment of the cost of said improvements, according to benefits, and an assessment thereof having been made and returned to said court the final hearing thereon will be had on the 6th day of August, A. D. 1900, or as soon thereafter as the business of the court will permit. All persons desiring may file objections in said court before said day, and may appear on the hearing and make their defense.  
The ordinance provides that the assessment is payable in ten annual installments, and the rate of interest four per cent.
