CITY ELECTION.

The city election for one alderman in each ward and a police magistrate for the whole city took place Tuesday, April 15, 1902, there being a polling place in each ward, with three judges and three clerks of election in each ward, at a cost to the city of \$3 each for the day's services. The official returns will be declared when the council meets and canvasses the votes May 6th, unless a special meeting is called before.

When the city council counts the votes and declares Elisha Morgan elected police magistrate he will have ten days in which to secure his bond in the sum of \$2,000, with two good securities and file it with County Clerk Hendee in Waukegan, who will immediately report the fact to Gov. Yates, who will proceed forthwith to issue a commission for Mr. Morgan, and send it to Mr. Hendee, who will duly enter the same on his records and forward it to Mr. Morgan. Having received his commission, and "sized it up," Judge Morgan can secure his supply of city blanks of Judge Hibbard, who keeps them in stock, and then tell City Marshall Fred Rudolph to "jerk up" some culprit and take him before "his honor," who will forthwith proceed to try the impecunious fellow and send him to the "pen" in default of fine paid.
