Following the trail of the footprints they found the body, which had just been washed ashore, at

11 p. m. about fifty feet south of the breakwater at the foot of Central avenue. Mrs. Andrews was the second wife of William E. Andrews, and about 30 years old. She had always been considered rather eccentric, and it is supposed she was temporarily deranged at the time of her death. Mr. Andrews enjoys the reputation of being an honest, industrious laboring man. However, he and his wife never enjoyed much domestic happiness and had quarrelled the day of the tragedy. Mr. Andrews has a young daughter about 12 years of age, who was removed from her home by the neighbors and placed in an institution, owing to the cruelty of the step-mother.
