

AN ORDINANCE

An Ordinance providing for the sale and conveyance of certain real estate belonging to the City of Highland Park, which is no longer necessary, appropriate, or required for the use of said city.

WHEREAS, The real estate hereinafter described and owned by the City of Highland Park, has been used and occupied as a public library site and has been under the custody and control of the Board of Directors of the Public Library, who have been conducting thereon a public library for the City of Highland Park, the said real estate having been purchased by said city for the use and benefit of the public library, and

WHEREAS, The Board of Directors of said Public Library, by resolution duly adopted, have declared said site unfit and unsuitable as and for a public library site and have further declared that they do not desire to use said property as and for a public library, and

WHEREAS, Said Board of Directors of said public library have further selected a new site and have arranged to purchase certain real estate for such site, and the City Council of said city is of the opinion that the real estate hereinafter described is no longer necessary, appropriate or required for the use of said City of Highland Park, or of said Public Library, or the Board of Directors thereof, and is no longer profitable to nor its longer retention is for the best interests of said city, therefore:

Be it ordained by the City Council of the City of Highland Park, County of Lake, and State of Illinois:

SECTION 1. That said real estate described as follows, to-wit: All that part of lot nine (9) in block twenty-two (22) in the City of Highland Park, described as follows: Commencing at the north-westerly corner of said lot, thence running northeasterly along the northerly line of said lot to a point in said northerly line distant one hundred (100) feet westerly measuring along said northerly line, from the northeasterly corner of said lot, thence northeasterly on a line parallel with the easterly line of said lot a distance of eighty-four (84) feet, nine and three-eighths (9 $\frac{3}{8}$) inches, thence southwesterly parallel with the northerly line of said lot to the west line of said lot, being the east line of Sheridan Road, thence north along said west line of said lot to the place of beginning, and situated in the county of Lake, in the State of Illinois; together with all the improvements thereon, and all rights, tenements, privileges and appurtenances thereunto belonging, or in any wise appertaining, and now being used for a Public Library, be, and the same is hereby ordered to be sold to the highest and best bidder for cash.

SECTION 2. That the bids or proposals for the purchase of said real estate shall be received up to the hour of eight o'clock p. m. of Tuesday, the 6th day of September, A. D. 1904, and may be filed with the City Clerk, and that such bids shall be opened at the regular meeting of the City Council of said City of Highland Park, to be held on Tuesday, the 6th day of September, 1904.

SECTION 3. If any bid as aforesaid shall be accepted at said meeting when said bids are opened, or any adjourned meeting thereof, and the purchase price paid, the Mayor and City Clerk of the City of Highland Park shall have the power, and they are hereby directed to convey said real estate, and transfer the same to such party or parties whose bids shall have been accepted and who shall have paid the purchase price, by proper deed or deeds of conveyance, stating therein the price therefor, to which deed the corporate seal of the City of Highland Park shall be affixed.

SECTION 4. This ordinance and notice of said sale shall be published for a period of not less than sixty days, in the Sheridan Road News-Letter, a newspaper published weekly in the City of Highland Park, there being no daily newspaper published in said city, the

same to be published and notice given in manner as provided by law. Such notice shall contain an accurate description of said real estate, the purpose for which it is used, and at what meeting the bids will be considered and opened, and shall be in the name of the City of Highland Park, by the Mayor of the City, and attested by the City Clerk.

NOTICE FOR LETTING CONTRACT.

Notice is hereby given that bids will be received for the construction of a cast iron lateral main water supply pipe, together with fire hydrants, shut off valves and special castings, to be constructed and laid along and under Roger Williams Avenue, in the City of Highland Park, County of Lake, and State of Illinois, connecting with the water main on Sheridan Road, at a point twelve feet south of the intersection of the center line of said Roger Williams Avenue, thence westerly parallel with the center line of said Roger Williams Avenue to the easterly line of Railroad Avenue, as a whole, in accordance with the ordinance therefor. Said bids will be opened on the 22d day of July, A. D. 1904, at the hour of 4 p. m. at the office of the Board of Local Improvements of said City, in City Building.

The specifications for such improvement and blank proposals will be furnished at the office of the City Clerk in the City Building.

The contractor will be paid in bonds, which will draw interest at the rate of five (5) per cent per annum.

All proposals or bids must be accompanied by a certified check payable to the order of the President of the Board of Local Improvements of the City of Highland Park for a sum not less ten (10) per centum of the aggregate of the proposal. Said proposals or bids must be delivered to the President of the Board of Local Improvements in open session of said board at the time and place fixed herein for opening the same. No proposal or bid will be considered unless accompanied by a check as herein provided.

The Board of Local Improvements reserve the right to reject any or all bids should they deem it best for the public good.
