The police took charge of the body and removed it to the city hall where a search of his pockets revealed a 25 ride bearer ticket good between Lake Forest and Chicago. Through this the remains were identified. Coroner Taylor was called and held an inquest, the verdict of the jury being "accidental death". Mr. Goltzsche's life was insured for \$3,000. He leaves a wife but no children.
