## City Council Meeting

Minutes of the regular meeting of the City Council of the city of Highland Park, held on Tuesday, May 2nd, 1905:

Minutes of previous meeting read and approved. Application was made by Sheahan and Crier for street sprinkling in the north district, and by Paul Borchardt in the south district, for the season of 1905. Motion carried that the matter of street sprinkling for the season of 1905 be referred to Fire and Water committee with power to act.

Moved and seconded to adopt an ordinance cres ating a department of public works for the city of Highland Park. Motion was lost.

Ordinance concerning the salaries of city officers for the term thereof as fixed by law is submitted for consideration of the council.

Moved and carried to amend the ordinance by adding the sum of \$5.00 per month to the salary of the General Helper.

Moved and seconded to amend the ordinance by adding the sum of \$5.00 per month to the salary of the city marshall. Motion lost.

Moved and carried that an amendment be made by adding the sum of \$150.00 per annum to the \_\_ salary of the city treasurer.

Moved and seconded that an ordinance concerning the salaries of city officers be adopted. Carried.

Moved and carried that the council adopt an ordinance amending Section 403 of Chapter 45 of an ordinance of said city, entitled "An ordinance revising and consolidating the general ordinances of the city of Highland Park, county of Lake, and state of Illinois."

Alderman Everett reports that no action has been taken by the Street and Alley Committee in the matter of stations along the line of the C. & M. E. Ry., and asks that time be extended in the matter.

Annual statement of Fire Marshall Bock is read. Motion to adjourn.

Upon adjournment of the City Council the aldermen-elect qualify by taking the oath of office. The clerk calls the roll.

Bergen, Alex. Robertson; chief fire marshal, Andrew Bock; assistant fire marshal. William Witten.

Moved and carried that report be referred to finance committee.

Motion that all appointments made by Mayor, with the exception of foreman of street work, is concurred in. Carried.

Motion that the appointment of Edward Nevins to the office of foreman of street work be concurred in. Carried.

Bond of Kenneth R. Smoot as city attorney in the sum of \$500 with Clarendon B. Eyer and Jane E. Smoot as securities is submitted for approval Motion that it be accepted is carried.

Motion prevailed for the adoption of an ordinance concerning the board of local improvements of the city of Highland Park and designating certain members of said board: "Be it ordained by the City Council of the city of Highland Park: That Alderman George W. Turner and James H. Shields, who are aldermen of the city of Highland Park, be and they are hereby designated and appointed members of the Board of Local Improvements of said city, together with the Mayor of said city, shall constitute said board, it being intended by this ordinance that said Board of Local Improvements shall consist of the Mayor and two members

Auditing committee reports progress in auditing of city accounts and that statement will be made when work is completed.

Motion to adjourn.
