The council has granted a petition for reorganizing the fire department. Considerable feeling has been extant due to the present arrangement of the volunteer company who, owing to their widely diverse places of residence, are unable to be on hand with quite the promptness requisite and the work of extinguishing the few fires that occur in the village, usually devolves on those persons who happen to be in the vicinity. The new organization will not hold a charter as the present institution does, and business matters will be entirely in the hands of the council. Some improvement over the present system is hoped for.

Several new residences will be erected on Sheridan road during the coming winter and spring. Mr. D. B. Nichols is building on the corner of Central avenue and Sheridan Road. Mr. Ben Newhall has recently sold the lot north of the Watson place on Sheridan Road. A fine residence property will be made of it. Frank M. Davis of Corning, Iowa, has sold to Robert P. Walker of Chicago, the east lot (310 feet on Park avenue) of the south half of block 16. Mr. Tobey of John C. Farwell & Co. of Chicago, has purchased two lots on Grove street. Mr. Tobey expects to build in the near future and, with his family will reside in Glencoe.

The ladies of the Library Club, have the cause of their pretty little town so much at heart that they are not content to furnish intellectual pleasure alone to the villagers but they must look to the comfort of the feet of their fellow Glencoeites also. Their interest has resulted in a petition by their Secretary, Mrs. P. Williams, to the village council, requesting that two plank sidewalks be laid where board walks have been torn up to make way for the placing of cement.
